Gentlemen:

Aztec Oil & Gas Company respectfully requests an exception to Rule 303 (a) and administrative approval to commingle Terry Blinebry and Drinkard production on the "State" Lease comprising Lots 3, 4, 5, and 6 of Section 2, Township 21 South, Range 37 East, Lea County, New Mexico. None of the wells on this lease is capable of producing top allowable; therefore, allocation of production will be based on periodic well tests.

The following facts are pertinent to this request:

- (1) Aztec Oil & Gas Company is owner and operator of the above described lease in which all working and royalty interests are common.
- (2) This lease, State of New Mexico Lease B-11613-1, involves State land, therefore, evidence that the Commissioner of Public Lands has consented to the proposed commingling is attached to this application.
- (3) A schematic diagram of the proposed installation is attached.
- (4) A plat showing the location of all wells on the subject lease and the pool from which each is producing is attached.
- (5) The average daily production, the known gravities and the value of each common source of supply are tabulated below for the months of July and August, 1970:

- (6) The anticipated gravity of the commingled liquid hydrocarbon production is 37.6° API. The daily value of 15.87 bbls at this gravity would be \$51.50, which is slightly above the sum of the values of production from each common source of supply.




*Proposed Commingling Facilities*

Your approval was received for an identical application filed August 24, 1964, however, subsequent producing characteristics of the lease prevented the commingling of production at that time.


