Gentlemen:

Reference is made to your application for administrative approval of an exception to Rule 303-A of the Commission Rules and Regulations to permit the commingling of Blinebry and Drinkard production on your C. P. Falby "A" Lease, which comprises the NW/4 of Section 8, Township 22 South, Range 37 East, Lea County, New Mexico, allocating the production on the basis of periodic well tests. It is our understanding that all of the production on this lease is of marginal nature.

By the authority vested in me under the provisions of Rule 303-B of the Commission Rules and Regulations, Texaco, Inc. is hereby authorized to commingle the production from the aforesaid pools on the said lease in the above-described manner, provided however, that the installation shall be operated in accordance with the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," and provided further, that you shall notify the Commission at such time as any well on either of the aforesaid pools is capable of top allowable production.

It is the responsibility of the producer to notify the transporter of the aforesaid commingling authority.





Gentlemen:

Your letter of July 20 requests approval to modify the commingling system approved by our letters of October 24, 1962, and May 26, 1965, lease Las Cruces 033706(a). Commingling of Eumont and Penrose-Skelly pool production with Drinkard pool production has been discontinued. You now propose to commingle Blinebry pool and Drinkard pool production on the leasehold in the NW $\frac{1}{4}$ sec. 8, T. 22 S., R. 37 E., Lea County, New Mexico, and allocate production to each pool on the basis of periodic well tests.


The system for commingling described in your letter and attachments thereto is hereby approved, subject to like approval by the New Mexico Oil Conservation Commission.
