Dear Sir:

Cities Service Oil Company respectfully request administrative approval of an exception to Rule 303(A) of the Commission Rules and Regulations to permit the commingling of the Blinebry and Drinkard pools into a common storage on our State "P" lease, well #1, Battery #2. This dually completed well is located in the NW/4 of the SW/4 Sec. 32-22S-38E, Lea County, New Mexico.

Both the Blinebry and Drinkard are marginal wells and we propose to allocate production on the basis of periodic well tests.

Latest well tests are listed below:






