A study has been made to revise the battery and commingle the production on the H. Corrigan lease. The lease is located in Sec. 4, T22S, R37E in Lea County, New Mexico.

The purchaser requests volumes and gravities of each zone and payment will be made accordingly. Therefore, no change in income by commingling is anticipated. Average volumes, gravities and values are as follows:

With oil production very low on this lease, it is critical to keep facilities at a minimum. Commingling will lower maintenance and operating costs. By lowering these costs, the economic limit will be reduced and therefore extend the producing life of the wells.

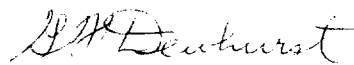

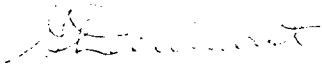
To Royalty Interest Owners:

A study has been made to revise the battery and commingle the production on the H. Corrigan lease. This lease is located in Sec. 4, T22S, R37E in Lea County, New Mexico.

There are presently six completions producing on this lease that are considered for commingling. Volumes and gravities will be closely monitored, so no loss in income is anticipated. Commingling the production will decrease the amount of surface equipment, which will lower maintenance and operating costs. Lowering these costs will lower the economic limit and therefore extend the producing life of the wells.

Production will be accurately metered to meet requirements set forth by the New Mexico Oil Conservation Commission.
