REQUEST FOR AMENDMENTS  
TO ADMINISTRATIVE ORDERS  
CTB-240 AND PLC-42,

Gentlemen:

Mobil Oil Corporation respectfully requests that Administrative Order CTB-240, dated July 27, 1972, be amended so as to permit the commingling of production from the North Vacuum Abo Pool for the State "JJ" Lease in the W/2 SW/4 Section 7, T17S, R35E, in addition to the presently commingled production from the State "MM" Lease and the State "A" Com. Lease in the E/2 SW/4 and S/2 SE/4 Section 7, T17S, R35E, Lea County, New Mexico.

The production from the State "JJ" Lease is presently commingled with production from the Bridges-State Lease by authority granted on April 4, 1972 in Administrative Order PLC-42; however, we now request that the State "JJ" Lease in the W/2 SW/4 Section 7, T17S, R35E, be deleted from said Order PLC-42 at a date to be concurrent with the effective date of the Proposed North Vacuum Abo Unit (Case No. 4830, September 27, 1972 NM000 Docket). (Expected date December 1, 1972).

All subject leases in this application have common ownership, working interest ownership, royalty ownership and O&M ownership. The production of all wells in this application are of marginal nature; therefore, we request that the permission granted in Order CTB-240 to allocate production to each well by quarterly well test be extended to this request.


