Dear Mr. Graham:

Mobil Producing TX & NM, Inc., is requesting an exception to Statewide Rule 303 B to commingle production from the recently completed Bridges State Well No. 506 with the commingled production from the Bridges State Well No. 120, Vacuum-Upper Penn and the Bridges State Well No. 165, Vacuum-Middle Penn. Administrative Order PC-100 granted that authority.

All wells to be commingle have common ownership, working interest ownership, royalty ownership and ORR ownership. There will be no decrease in value of the crude because of commingling. The wells will be tested prior to commingling. Pertinent information is:





Well Location Plat


PRESENT
