Gentlemen:

Please accept this application for Administrative approval for exception to Rule 303(A) to permit commingling in a common storage facility of production on my Cossatot "C" Lease. The No. 2 well will be a single completion in the Drinkard Pool. The No. 3 and No. 4 wells will be dual completions in the East Brunson Granite Wash Pool and in the Drinkard Pool. Application for approval of a dual completion of Well No. 1 has been approved by your office. Application for approval of dual completion of the No. 3 and No. 4 well will be submitted to your office within a short time.

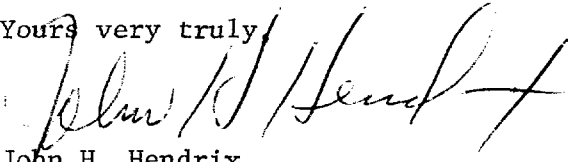
The following is submitted in support of this application:

1. Schematic diagram of the proposed installation.
2. A plot showing location of lease and wells.
3. Production from the Wantz Granite Wash will not exceed 150 BOPD. Gravity is 40° API, having a value of \$4.16 per barrel.
4. Production from the four Drinkard wells will not exceed 120 BOPD. Gravity is 40° API, having a value of \$4.16 per barrel.
5. Anticipated gravity of the commingled production is 40° API, having a value of \$4.16 per barrel.
6. Working interest and royalty interest is identical for each well and each zone.
7. This is a fee lease involving no state or federal lands.
8. Liquid hydrocarbon production from each common source of supply is to be accurately measured or determined prior to commingling in accordance with the applicable provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities".

The applicant states specifically that the actual commercial value of such commingled production will not be less than the sum of the values of the production from each common source of supply.

Your early consideration of this application will be appreciated.

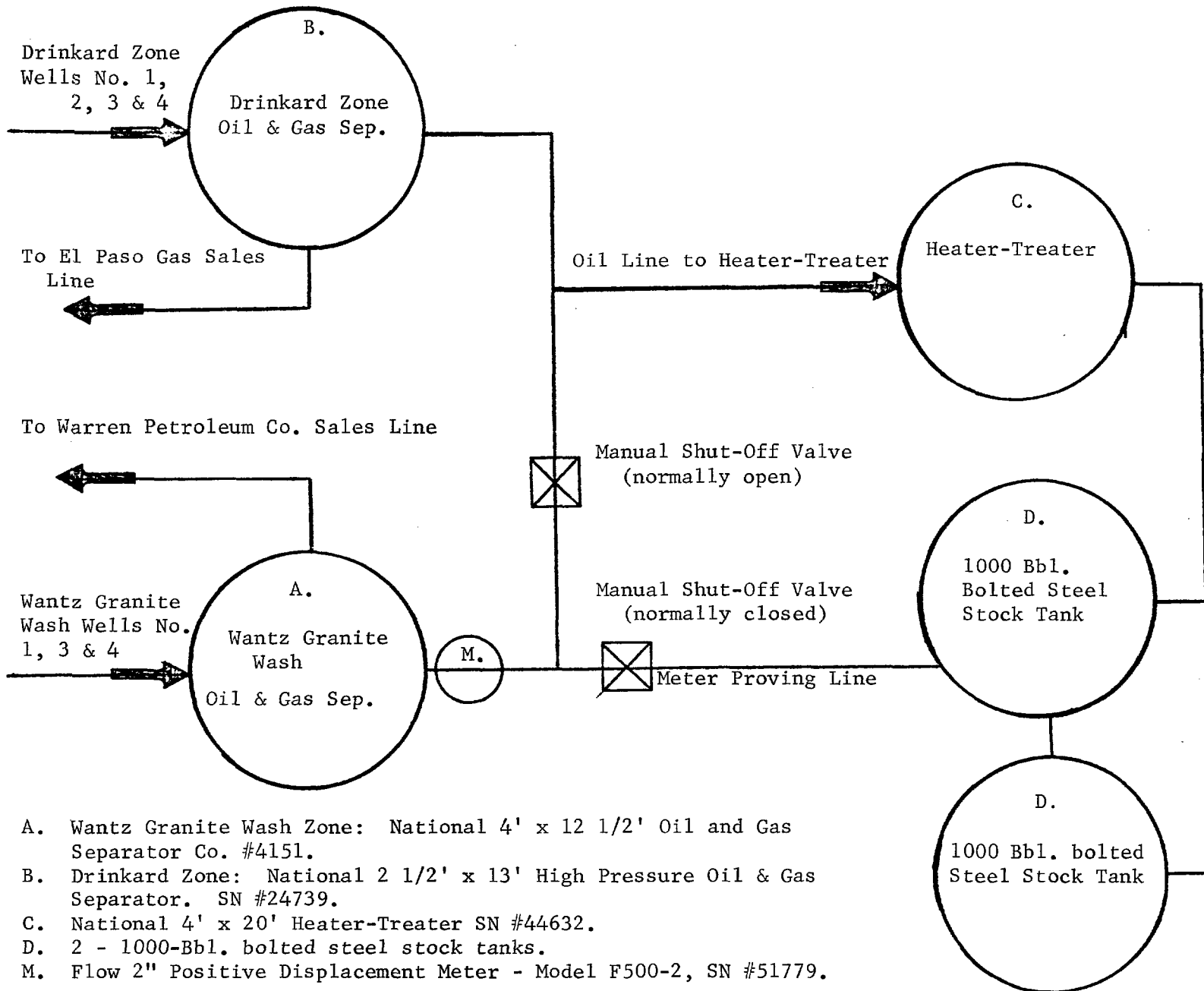

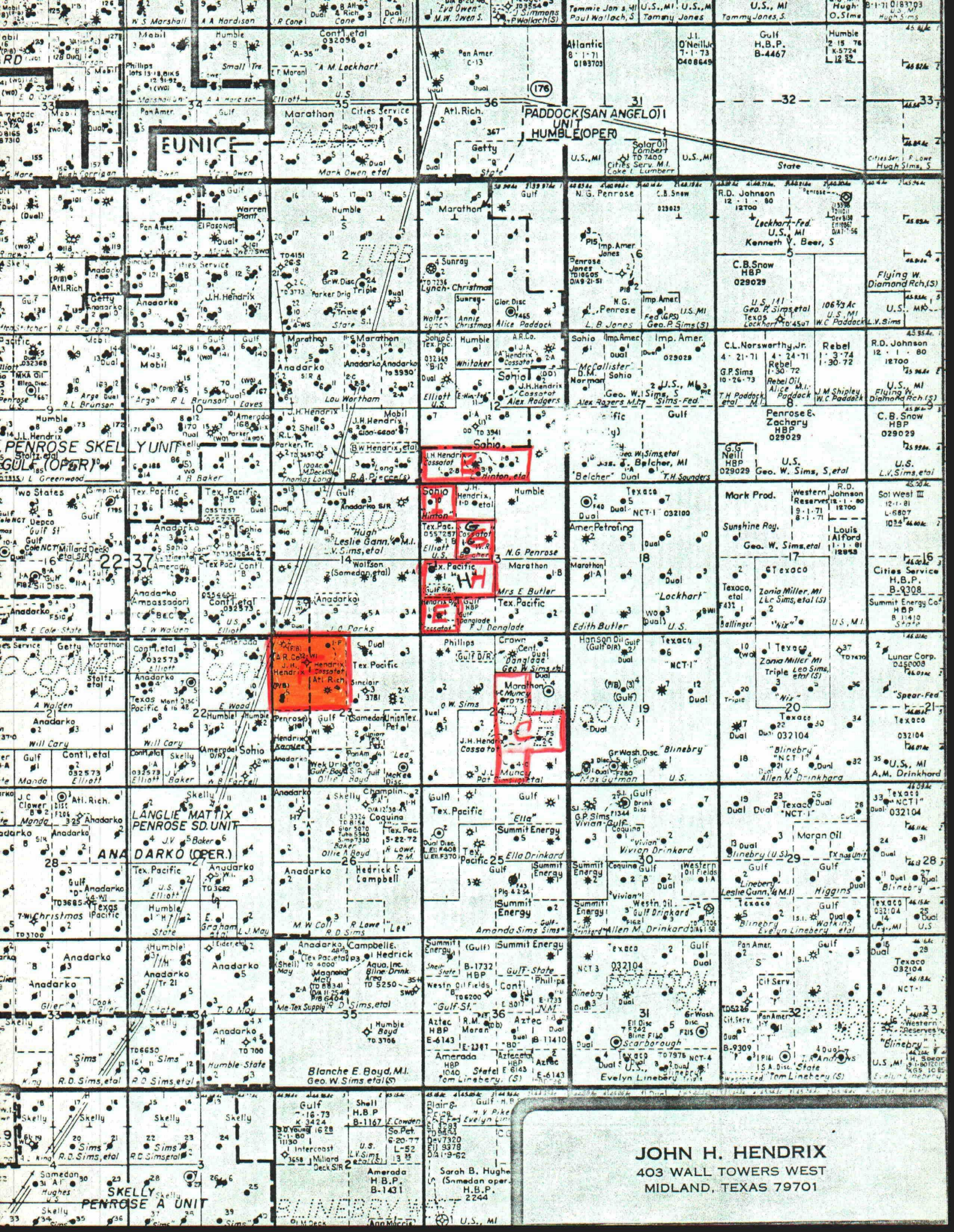

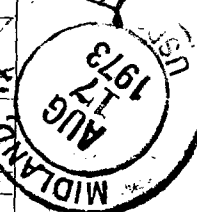
Schematic Diagram of Commingle Installation
