SURFACE COMMINGLING
New Mexico "BH" State Lease

ATTENTION: MR. JOE D. RAMEY

Gentlemen:

In accordance with New Mexico Oil Conservation Commission Rule 303-B, Texaco Inc. respectfully requests permission to surface commingle hydrocarbon production from the Lea Undesignated Strawn Gas pool with that from the Undesignated Wolfcamp Oil pool on the New Mexico "BH" State lease and to determine production from individual wells and pools by periodic well tests.

The gravity of the Lea Undesignated Strawn Gas condensate is 47.8° API with a value of \$11.65 per barrel and estimated production of 1 barrel per day. The gravity of the Undesignated Wolfcamp crude is 37.9° API with a value of \$11.65 per barrel and estimated production of 14 barrels per day. The value of the commingled production will be the same as the sum of the values of the production from each common source of supply.

A plat of the New Mexico "BH" State lease indicating well locations and pools from which they produce is attached.

All working interests and royalty interests are common throughout.

A copy of this application is being sent to the Commissioner of Public Lands for the State of New Mexico for their approval. You will be furnished a copy of their approval when it is obtained. The Texas-New Mexico Pipe Line Company as purchaser of the crude oil from this lease is also being furnished a copy of this application.


