Gentlemen:

Chevron U.S.A. Inc. respectfully requests an exception to Rules 303-A and 309-A to save considerable expense in building and maintaining a new battery for the A. L. Christmas NCT-C #7 well. The current battery will be used for the Arrowhead Grayburg Waterflood Unit, and if we are permitted, the number 7 well can be surface commingled into the existing A. L. Christmas NCT-C #9 tank battery.

The A. L. Christmas NCT-C #9 Battery has 8 wells, (3 Blinebry, #9, #15 & #16, and 5 Drinkard, #10, #11, #12, #13 & #15), producing into it with an average of 30 BOPD. The number 9 battery has been authorized to commingle production from the Tubb and Drinkard pools by Commingling Order PC-557, and the Blinebry, Drinkard and Wantz Abo by Amended Commingling Order PC-383. It is desired to surface commingle the A. L. Christmas NCT-C #7 well producing from the Eumont Pool at 3 BOPD.

On completion of the surface commingling of production from the subject leases, it should be noted that provisions will be incorporated to allow for individual well testing and proper allocation of production for each pool. Also, royalty interests within each pool underlying the two leases will be maintained and the purchaser will accept the commingled production. Attached is a tabulation showing individual pool gravities, production and revenues along with the expected commingled values. Also attached are battery schematics, a brief production history of each well, and a lease plat.

Therefore, to avoid waste by building separate facilities for the A. L. Christmas #7 well and avoid premature abandonment of the well, Chevron respectfully requests the NMOCD grant approval of this application for exception to Rules 303-A and 309-A and allow Chevron to commingle production from the A. L. Christmas NCT-C #7 well with the A. L. Christmas NCT-C #9 Battery.
