Conoco Inc. requests administrative approval under the provisions of Rule 303-B, to surface commingle production from the Warren Unit No. 81, Warren Tubb Oil Zone with production from the Blinebry Oil & Gas Zone from Warren Unit No. 36. Oil from both zones will be produced into a common tank battery, located in the NW/4 NE/4 of Section 28, T-20S, R-38E, Lea County, New Mexico.

Ownership and working interest for both zones is common. Commingling will not reduce the commercial value of the production. The value of production is as follows:


