Gentlemen:

Chevron U.S.A., Inc. respectfully requests an exception to Rules 303-A and 309-a to save considerable expense in building and maintaining a new battery for the Lillie #1 well that was recently recompleted in the South Fowler Tubb. It is desired to commingle the South Fowler Tubb production into a new battery located in Section 23, T24S, R37E, Lea County, New Mexico with production from Lillie #1 Battery (Fowler Upper Yeso) and Lillie #3 Battery (Fowler Ellenburger).

The existing Lillie #1 Battery had production from Lillie #1 well in the Fowler Montoya and Lillie #2 and #4 wells in the Fowler Upper Yeso under Commingling Order PC-606. The Fowler Montoya has been plugged and abandoned and recompleted in to South Fowler Tubb. The Lillie #3 Battery has production from Lillie #3 well in the Fowler Ellenburger.

We would like to abandon both existing batteries and build a new battery for the four wells. The existing batteries need extensive repair. Average production from the #1 battery is 19 barrels of oil per day. Average production from the #3 battery is 7 barrels of oil per day.

On completion of the surface commingling of production from the subject lease, it should be noted that provisions will be incorporated to allow for individual well testing and proper allocation of production for each pool. Also, royalty interests within each pool underlying the lease will be maintained and the purchaser will accept the commingled production. Attached is a tabulation showing individual pool gravity's, production and revenues along with the expected commingled values. Also attached are battery schematics, a brief production history of each well and a lease plat.

To avoid waste by building separate facilities for the Lillie #1 well and maintaining three separate facilities, and avoid premature abandonment of the wells, Chevron respectfully requests the NMOCD grant approval of this application for exception to Rules 303-A and 309-A and allow Chevron to commingle production from the South Fowler Tubb, Fowler Upper Yeso and Fowler Ellenburger.

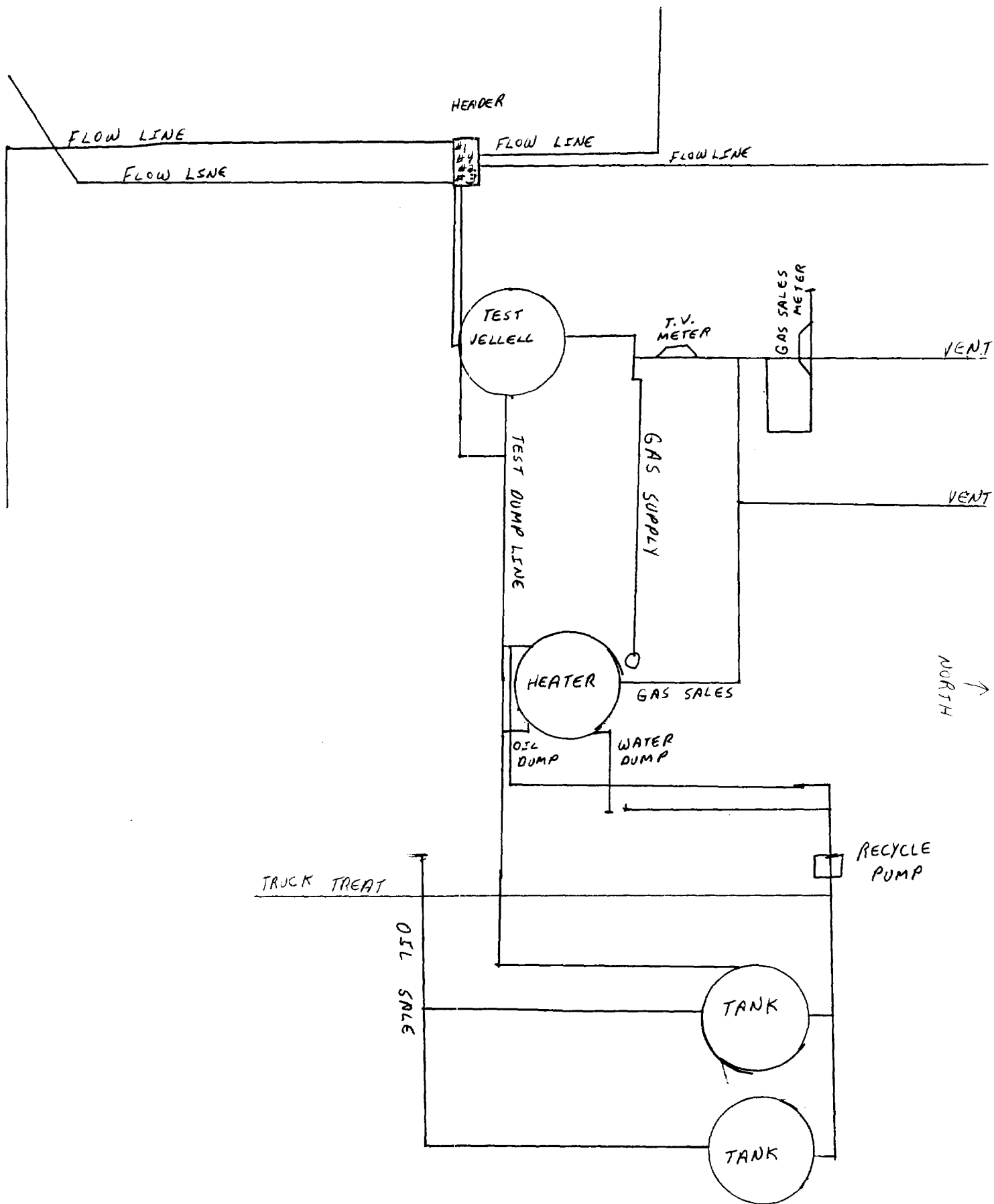

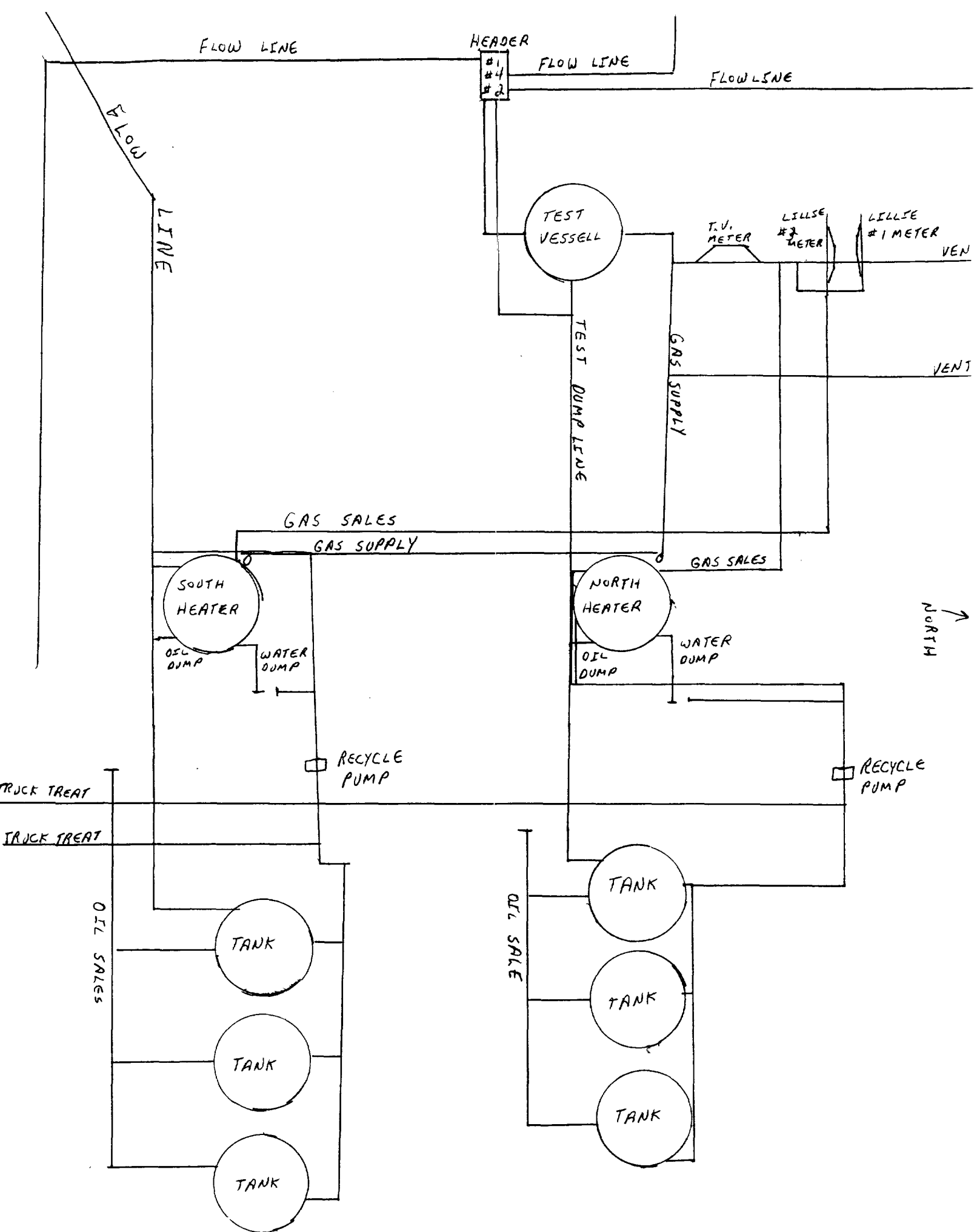
