This office is in receipt of your letters of August 20, 1992 and September 11, 1992 wherein you have requested our approval to surface commingle the Gallup and Dakota condensate from the Rincon Unit Well No. 130-E located on State Lease No. E-290-28.

According to the information provided, the Rincon Unit Well No. 130-E is a development gas well scheduled to be drilled and completed as a Dakota/Gallup producer and therefore, request our approval to surface commingle the produced fluids from individual separators into a common stock tank.


Since it appears that there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request for surface commingling of the condensate production from the Rincon Unit Well No. 130-E, is hereby approved. Any deviation from the substance of your request will be sufficient grounds for rescinding our approval.
