

Reference is made to your recent letter requesting an extension before implementation of bi-annual well tests required to determine allocation of pool production on the subject wells. This request is made due to unstable producing conditions during the winter months as well as engineering complications involving production compression and/or lower line pressures. Amoco Production Company may determine allocation by inferring data from historical production percentages for individual pools until no later than June 1994, at which time bi-annual well testing will commence as specified in the referenced Division Orders.
