Gentlemen:

Reference is made to your letter of October 26, 1964, wherein you request authority to commingle Vacuum-Abo, Vacuum-Pennsylvanian, and Vacuum-Wolfcamp production from the following leases, all in Lea County, New Mexico:

B-1501 W/2 SE/4 Section 30, T17S, R35E
B-1606 SW/4 NW/4 and NW/4 SW/4 Section 31, T17S, R35E
B-1861 SW/4 SE/4 Section 31, T17S, R35E
B-1502 NW/4 Section 5, T18S, R35E

It is our understanding that the production from each pool will be separately metered prior to commingling, and that allocation of production to each of the several leases will be on the basis of periodic well tests. Each of the leases has a common working interest and the royalty interest is also common throughout.

Pursuant to the authority granted me under the provisions of Rule 303 (b) and Rule 309-B of the Commission Rules and Regulations, you are hereby authorized to commingle the production from the afore-said pools and leases in the above-described manner. Provided however, that the installation shall be operated in accordance with the Commission "Manual for the Installation and Operation of Commingling

Dear Sir:

Phillips Petroleum Company hereby applies for Administrative exception to Rule 309-A to commingle production from four separate State Land leases into one central tank battery. These leases are described as follows, all in Lea County:

- B-1501 W/2 SE/4 Section 30, T17S, R35E
- B-1606 SW/4 NW/4 and NW/4 SW/4 Section 31, T17S, R35E
- B-1861 SW/4 SE/4 Section 31, T17S, R35E
- B-1502 NW/4 Section 5, T18S, R35E

Each of the wells on these four leases produce from the Vacuum Glorieta Pool and are presently producing into the Santa Fe Lease Battery No. 18.

There is attached a copy of the Commissioner of Public Lands letter that approves the commingling of production from these leases. Also, there is attached a plat showing the locations of the leases, well and battery, and a sketch of the tank battery equipment and testing facilities. Also, there is attached a copy of the pipe line company's letter, stating that they agree to the commingling of the four leases.

Each of these leases has a common working interest and the royalty interest is also common throughout. The allocation of production to each of the leases is on the basis of periodic well tests.

Production from three pools is presently being commingled into Santa Fe Battery No. 18 as authorized by amended Administrative Order PC-181. A copy of this order and a copy of the Commissioner of Public Lands letter approving the commingling between pools are attached.
