COMMINGLING ORDER CTB-33

Section 24, T-25-S, R-37-E, Lea County, N.M.

The above-named company is hereby authorized to commingle production from the following pools: Justis-Fusselman, Justis-Ellenburger, and Justis Montoya in a common tank battery and to determine the production from each pool by well tests and to commingle Justis Blinebry, Justis Tubb-Drinkard, Justis Paddock, and Langlie Mattix Seven Rivers Queen production in a separate system and to determine the production from each pool by well tests.

It is our understanding that the ownership of each of the aforesaid leases is identical throughout.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: This amended Administrative Order authorizes the commingling of the Justis Paddock and Langlie Mattix Pool production with the previously approved Justis Blinebry and Justis Tubb-Drinkard Pool production.

Gentlemen:

Texaco Producing Inc. respectfully requests permission for surface commingling of Justis Paddock pool production from the A. B. Coates "C" Well No. 6 and Langlie Mattix Seven Rivers Queen pool production from the A. B. Coates "C" Well No. 2 with Justis Blinebry and Justis Tubb Drinkard pool production from the A. B. Coates "C" (LC-032650b) and A. B. Coates "D" (LC-032650a) Leases.

Currently, Justis Blinebry and Justis Tubb-Drinkard pool production from the A. B. Coates "C" and A. B. Coates "D" Leases is surface commingled according to Administrative Amendment Commingling Order PLC-33 dated February 26, 1974. Justis Montoya pool production from A. B. Coates "C" No. 14 and Justis Fusselman pool production from A. B. Coates "C" No. 12 and A. B. Coates "D" No. 2 are also produced into the sour Blinebry and Tubb-Drinkard battery under individual downhole commingling orders.

Justis Paddock pool oil production from the A. B. Coates "C" Well No. 6 is surface commingled with the Justis Blinebry and Justis Tubb-Drinkard pool production under a temporary commingling request approved May 16, 1985 following recompletion of the well. Gas production from Well No. 6 is metered separately due to its gas well status. The A. B. Coates "C" Well No. 6 tested for 6 BOPD, 25 BWPD and 722 MCFPD, but is currently shut-in pending a gas connection.

Langlie Mattix Seven Rivers Queen pool production from the A. B. Coates "C" Well No. 2 is being handled by a separate one-well battery. Current production is marginal (2 BOPD).

The volumes of the liquid hydrocarbons are as follows:

The expected gravity of the liquid hydrocarbons is 36.43°.

Oil prices will not change due to either commingling request. Allocation of production will continue to be made by well tests (Paddock gas will be metered separately). Attached is a schematic of the sour and sweet batteries for the A. B. Coates "C" and A. B. Coates "D" Leases. The sour battery contains Justis Blinebry, Justis Tubb-Drinkard and Paddock production. The sweet battery contains Justis Montoya, Justis Fusselman and Justis Ellenburger production. The proposed surface commingling of the Langlie Mattix Seven Rivers Queen production in the sour battery is also shown.
