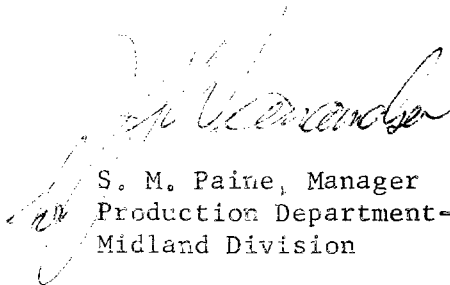

Shell Oil Company hereby gives notice of intent to commingle Blinebry and Drinkard production from the Grimes Lease into the Grimes Central Battery. Both zones will be separately metered and sampled before commingling with the above leased commingled San Andres production. The allocation of production as to each lease and the installation and operation of commingling facilities will be in accordance with the New Mexico Oil Conservation Commission commingling rules and regulations. No change in the commercial value of the production is anticipated due to the similar gravities.

All parties owning an interest in the subject leases and the purchaser of the commingled production are being informed of this intent. The New Mexico Oil Conservation Commission may approve the commingling if no party has made objection within twenty (20) days of receipt of our application.
