A study has been made to consolidate the batteries and commingle the production on the J. G. Randle and J. G. Randle "A" leases. These leases are located in the Eunice Field, Sec. 20, T21S, R37E in Lea County, New Mexico.

There is one well producing from the Drinkard on the J. G. Randle lease and one Blinebry gas well producing on the J. G. Randle "A" lease. Average gravities, volumes and values are as follows:

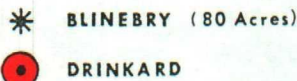

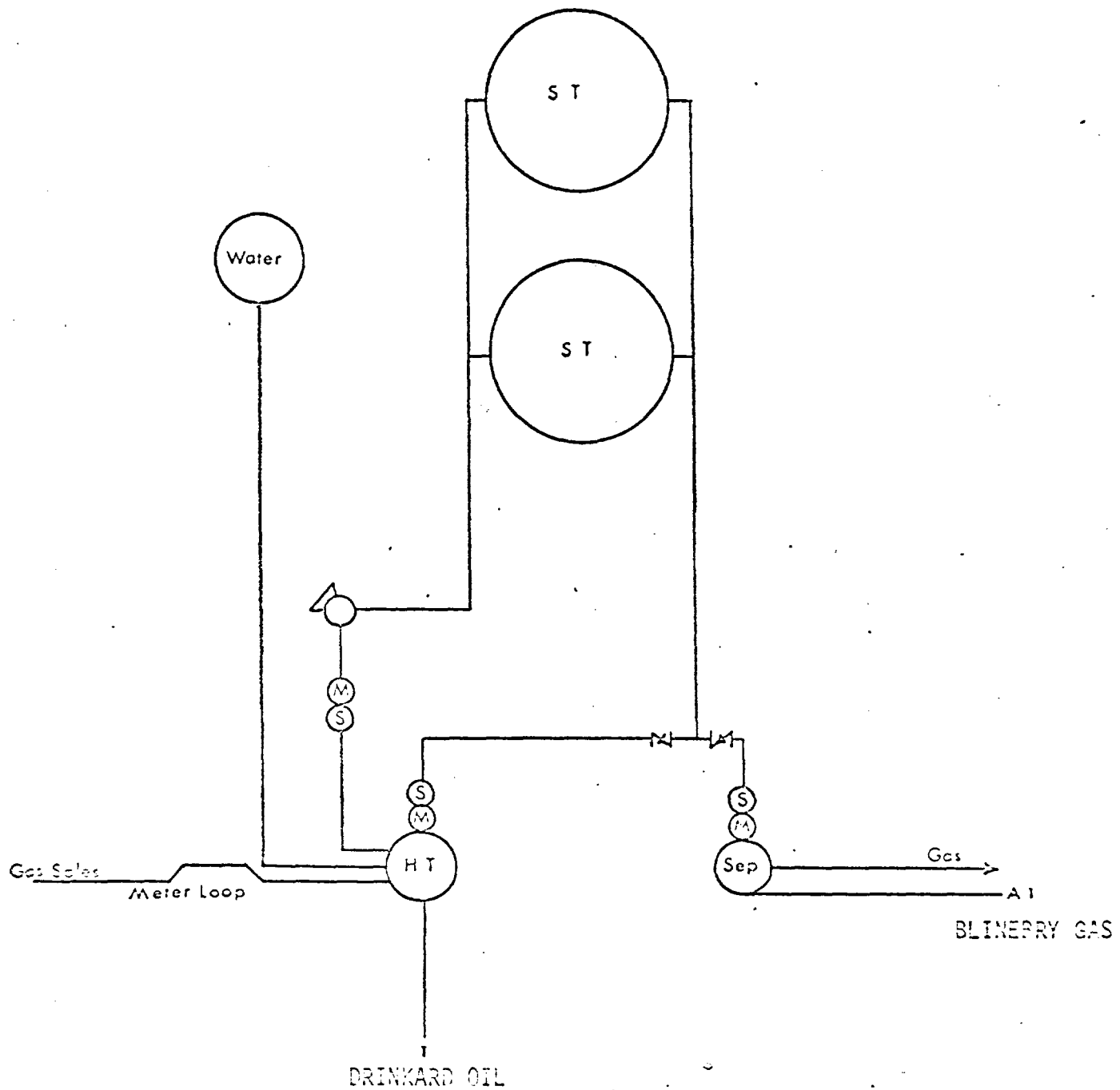

As purchaser of the concerned production, Mobil is agreeable to your commingling as you stated in your letters, which is as follows:

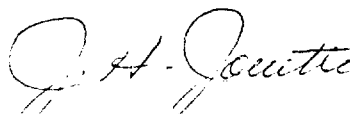

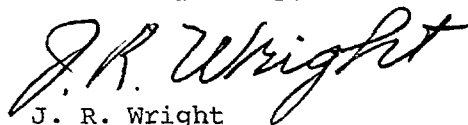

To Royalty Interest Owners:

A study has been made to revise the battery and commingle the production from the J. G. Randle and J. G. Randle "A" leases. These leases are located in Sec. 20, T21S, R37E, in Lea County, New Mexico.

There is presently one well producing from each lease. Commingling the production will lower the maintenance and operating costs by decreasing the amount of surface equipment. Lowering these costs will lower the economic limit and therefore extend the producing life of the wells.

No loss in income to the royalty owner is anticipated. Production will be accurately metered to meet the requirements set forth by the New Mexico Oil Conservation Commission.
