

Amendment To PC-473 - Wimberly lease

Continental Oil Company proposes to amend PC-473 which gave authority for pool commingling on the Wimberly lease located in sections 11 and 12, T-24S, R-32E, Lea County, New Mexico.

It is now proposed to add to this commingled production the production from Wimberly A No. 1. This lease is located in section 13, T-24S, R-32E, Lea County, New Mexico. This well is producing from the Double X Delaware Pool at the rate of 15 barrels oil per day.

There is no difference in royalty owners between the Wimberly and Wimberly A leases. There will be no penalty price-wise as a result of this proposal.

Attached is a schematic showing of the proposed commingled installation and a plat showing battery location and wells to be served, and a letter of approval from USGS.

Your early approval of this proposal is respectfully requested.






