
Gentlemen:

Getty Oil Company respectfully requests approval to commingle the oil production on its State "BB" and State "L" leases in accordance with Rule 309-B of the New Mexico Oil Conservation Commission Rules and Regulations.

In support of this application, the following information is submitted:

1. All production is from the Justis Blinebry and Tubb Drinkard pools which are commingled down hole in each well.
2. Working interest ownership and royalty ownership is common for these two (2) leases.
3. Attached is a plat showing the location of the wells and leases.
4. Attached is a schematic diagram of the proposed commingling facility located on the State "L" lease.
5. Production is to be allocated based on monthly well tests.

There is only one well on the State "BB" lease and two on the State "L". The State "BB" Well No. 2 is making 8 BOPD, State "L" Well No. 3 is making 25 BOPD, and State "L" Well No. 4 is making 32 BOPD. In the interest of conservation and for continued economic operation of these leases, Getty Oil Company submits this request to commingle.







Lea County, New Mexico




GETTY OIL COMPANY
