

We are in receipt of your request on behalf of David Fasken to commingle production from the Consolidated State Well No. 2 located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, of Section 8, T-17S-R37E being produced from the Strawn formation and the Consolidated "A" State Well No. 1 located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 8, T17S-R37E being produced from the Devonian formation.

We regret to inform you that we cannot grant you approval being that there are two different Institutions involved.

Enclosed is our Rule 1.053 which strictly prohibits the commingling of different Beneficiary Institutions.

Therefore, we are returning your application unapproved.

Gentlemen:

On behalf of our client, David Fasken, we are requesting an exception to Rule 303-A of the Division Rules and Regulations to surface comingle oil production from two different reservoirs - Strawn and Devonian - Rule 303-B. A plat of the leases with the two wells involved is enclosed. The commonly owned production will be metered prior to combining the two streams per Fig. 1 of Manual for the Installation and Operation of Commingling Facilities.


The value of the comingled production will be increased by \$25.50 per day or 30¢/Bbl. for the Strawn production. The purchaser P. & O. Falco, Inc. has agreed to pay the top price or \$35.30 per barrel for the comingled crude oil. Please refer to attached tabulation.
