Gentlemen:

On behalf of our client, David Fasken, we are requesting exception to the requirements of Rule 309-A of the Division Rules & Regulations and for administrative approval, commingling of production from two separate leases in a common tank battery - Rule 309-B.

A plat of the two wells on two separate leases showing their locations is enclosed. The No. 2 Consolidated State is a Strawn completion and the No. 1 Consolidated "A" State is a Devonian completion, therefore a separate request for exception to Rule 303-A is also being filed.

These are one well producing leases at this time and the two oil streams will be commingled down-stream of individual meters and emulsion treaters. Essentially the same physical surface equipment as illustrated in Fig. 1 of the Manual For The Installation And Operation of Commingling Facilities.

A tabulation of all interest owners in these leases is enclosed. Each owner was notified by certified mail of this request to commingle and each was provided a waiver letter to execute. The crude oil purchaser P&O Falco, Inc., Shreveport, La. was also notified by certified mail.

On behalf of our client, David Fasken, we are requesting permission from the New Mexico Energy and Minerals Department, Oil Conservation Division to do two things:


1. Comingle production from two separate leases - Rule 309-B.

Gentlemen:

On behalf of our client, David Fasken, we are requesting exception to the requirements of Rule 309-A of the Division Rules & Regulations and for administrative approval, off-lease storage, Rule 309-C, for the subject lease. This request is based upon further utilization of existing equipment and storage facilities, the present connection into Texas-New Mexico Pipeline and elimination of duplicate facilities with an installed cost on the order of \$90,000.00.

A plat is attached showing a tank battery location in Unit G, Sec. 8, T-17-S, R-37-E, Lea County. This tank battery was constructed to serve the Consolidated State Lease, and off-lease storage was approved for that lease on June 29, 1981.

The Consolidated State Lease, No. E-8563, includes N/2, NE/4 and SW/4 Sec. 8, T-17-S, R-37-E and the W/2 Sec. 9, T-17-S, R-37-E, Lea County, while the Consolidated "A" State Lease, No. E-8563, covers only the S/2, SE/4 Sec. 8, T-17-S, R-37-E, Lea County (Please refer to attached plat).




INDIVIDUAL TREATERS USED IN COMMINGLING
