This office is in receipt of your Application to Surface Commingle Production from all Conoco-Operated leases in the Dagger Draw Area, Eddy County, New Mexico. Your application makes reference to the Dee State Com Well No. 1 located in the NW/4SE/4 of Section 36, Township 19 South, Range 24 East, being State owned lands.

We regret to inform you that your application dated December 27, 1984, for permission to Surface Commingle Production from the Dagger Draw Area, Eddy County, New Mexico can not be approved as to State Lands. Our Statutes strictly prohibit the commingling, confusion or the intercommunication of production from any other trust lands or any lands not belonging to the State of New Mexico.

Enclosed is a copy of our rules and regulations Nos. 1.053, 1.054 and 1.055 in regards to Commingling and Off Lease Storage of oil and gas on State Trust Lands.
