
LEASE NAME: Pardue Farms Lease

Oryx Energy Company respectfully requests an exception to Rule 309-A to permit commingling of the production from the following leases/fields in Eddy County, New Mexico:

An exception to Rule 303(a) is not required as no downhole commingling is or will be occurring. This request is for surface commingling only.

Attachment A shows the leases in question and their locations with respect to one another. Attachment B is a drawing of the proposed facility and tie-in points for the sale of the production. Low pressure gas off the heater treaters will be totaled and allocated back to each lease based on fluid tests from each well/ lease. Each lease will be metered prior to any commingling.






