Both in Lea County, New Mexico.


The above-named company is hereby authorized to commingle West Corbin-Delaware, South Corbin-Wolfcamp and South Corbin-Bone Spring Pool production in a common tank batter. Production from the subject leases shall be determined as follows:

- (a) Production from the Federal "MA" Well Nos. 6 and 7, and from the Aztec "22" Federal Well No. 3, West Corbin-Delaware Pool shall be individually and separately metered prior to commingling.
- (b) The remaining production shall be allocated on the basis of well tests.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

FURTHER: This order supersedes Division Administrative Order PC-767, as amended.
