Dear Ms. Cole:

Reference is made to your application submitted to the New Mexico Oil Conservation Division ("Division") on September 6, 2000 for an exception to the well location requirements provided within the: (i) the "*Special Rules for the Blanco-Mesaverde Pool*," as promulgated by Division Order No. R-10987-A, issued in Case No. 12069 dated February 1, 1999; and (ii) the "*Special Rules for the Basin-Dakota Pool*," as promulgated by Division Order No. R-10987-B, issued in Case No. 12290 dated June 30, 2000, as amended by Division Order No. R-10987-B (1), for Burlington Resources Oil & Gas Company's ("Burlington") proposed Seymour Well No. 3-B (API No. 30-045-30147) to be drilled at an unorthodox gas well location in both the Blanco-Mesaverde and Basin-Dakota Pools 2305 feet from the South and East lines (Lot 10/Unit J) of Section 24, Township 31 North, Range 9 West, NMPM, San Juan County, New Mexico.

Gas production from the Blanco-Mesaverde Pool is to be included in an existing standard 319.37-acre stand-up gas spacing and proration unit comprising Lots 1, 2, 7, 8, 9, and 10 and the S/2 SE/4 (E/2 equivalent) of Section 24, which is currently dedicated to Burlington's: (i) Seymour Well No. 3 (API No. 30-045-10433), located at a standard gas well location 800 feet from the North line and 1800 feet from the East line (Lot 2/Unit B) of Section 24; and (ii) Seymour Well No. 3-A (API No. 30-045-21761), located at a standard infill gas well location 1190 feet from the South line and 1020 feet from the East line (Unit P) of Section 24.

The E/2 equivalent of Section 24, being a standard 319.37-acre gas spacing and proration unit for the Basin Dakota Pool, is also to be dedicated to the proposed Seymour Well No. 3-B.

The application has been duly filed under the provisions of Division Rules 104.F and 605.B and the applicable rules governing both pools.

By the authority granted me under the provisions of Division Rule 104.F(2), the above-described unorthodox Basin-Dakota/Blanco-Mesaverde gas well location for the Seymour Well No. 3-B is hereby approved. All of the aforementioned wells and both spacing units will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest,
