

Dear Mr. Stonger:

On December 5, 2000 the La Huerta 32 #1 was spud with Patterson Rig #55. On December 13, 2000, the rig was skid due to severe hole instability near the surface which caused us to loose the hole and the BHA in the hole at the time. The rig was moved to the south 151' to get a comfortable distance away from possible caverns created by the original hole. The replacement wellbore was inadvertently spud 2 feet closer to the East lease line.

As per our conversation at 1:30 pm Monday December 18, 2000, I am submitting copies of the forms requested showing the rig move from 660 FNL & 1980 FWL of 32-21S-27E to 811 FNL & 1982 FWL of 32-21S-27E.

Please find enclosed a copy of the Application for Permit to Drill (Form C-101) for the original La Huerta 32 #1 well (prior to skid), a copy of the applicable unit plat (Form C-102) showing the location of La Huerta 32 #1-Y well (after skid), and a copy of the Sundry Notice (Form C-103) of La Huerta 32 #1-Y well (after skid) regarding the location change.


