Dear Mr. Stogner:

Energien Resources Corporation requests administrative approval of unorthodox locations (off pattern) for its Bullridge #100 and Bullridge #101 wells under the provisions of NMOCD R-8768-B.

The E/2, E/2W/2 of Section 33, T32N-R5W is within the Carson National Forest, the W/2W/2 of Section 33 is in the Carracas Mesa Special Management Area. Both areas are extremely sensitive environmentally and archeologically. Further the Carracas Mesa Special Management Area is subject to seasonal closures and severe restrictions on surface disturbance proposals. (see enclosed guidelines).

The Schalk 62 #3 well located 1,170' FSL & 790' FEL (SE/4SE/4) of Section 33-T32N-R5W was spud September 1, 1974, completed as a Blanco Mesaverde well on December 15, 1974 at a total depth of 5,850' and recompleted as a Wildcat Mancos Pictured Cliff on June 23, 1994, at which time the Blanco Mesaverde Zone was Abandoned. The well last produced in October 1991, and has cumulatively produced 68,004 Mcf/g. Energien Resources Corporation is reviewing the status of the wellbore to determine whether it can be salvaged or if we will plug & abandon it.

The Schalk 62 #2 well located 1,760' FNL & 1,190' FWL (SW/4NW/4) of Section 33-T32S-R5W, was completed August 12, 1973 as a Rosa Gallup producer at a total depth of 7,717'. The well was plugged and abandoned June 23, 1998 after producing 101,983 Mcf/g.


When conducting preliminary site reviews with both the Bureau of Land Management and Forest Service each requested (ferverently) that we locate our proposed Fruitland Coal wells on the existing Schalk 62 #2 & 3 well pads.

Our proposed location for the Bullridge #100 is 1,195' FSL & 845' FEL of Section 33-T32N-R5W, being the same well pad as the Schalk #100, and for our Bullridge #101 is 1,835' FNL & 1,095' FWL of said Section 33, being the same well pad as the Schalk 62 #2 well. Both locations are off pattern as they are in the SE/4 and NW/4 respectively, rather than the NE/4 and SW/4, necessitating we seek approval for unorthodox locations for both wells.

A copy of this application is being submitted to offset operators by certified mail with a request that they furnish your office in Santa Fe with a Waiver of Objection.

Attached are well location plats showing dedicated acreage, a topographic plat of the area, a map showing all offsetting operators and requests from the district Ranger of the Carson National Forest and the Environmental Protection Team Leader of the Bureau of Land Management for unorthodox locations.





San Juan 30-4 Well #102, T. 30 N., R. 4 W. Sec. 18, 1450'FNL/710'FWL**

The mineral operator is required to comply with other applicable regulations such as the Endangered Species Act and the Archeological Resources Protection Act under 36 CFR 228.112(c). The operator is also required under 36 CFR 228.108(c) to minimize or prevent damage to surface resources. The Carson National Forest Management Plan states that surface resource impacts will be minimized when administering mineral resources.

The following conditions apply which require unorthodox locations:

Prevention of unnecessary resource damage requires the locations be unorthodox. (Such as a previously disturbed area or existing road available outside the drilling window.)
