Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

It is understood that this unit is to be ascribed to your State "E-20" Well No. 1, located 660 feet from the south line and 1980 feet from the west line and in the SE/4 SW/4 of Section 20, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5 (b), Section 6 of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 160 acres.
