Gentlemen:

The subject application was received in your office at Santa Fe, New Mexico, on March 7, 1956 and placed on your docket as No. DC-86 as to that portion of said application requesting authority to dually complete the subject well and as No. NSP-251 as to that portion of said application requesting authority to allocate a non-standard gas proration unit in the Tubb Gas Pool to the subject well. Authority to dually complete said well had previously been granted by your Honorable Commission under date of March 19, 1954.

Continental Oil Company has obtained a photostatic copy of the letter dated March 30, 1956, and received in your Santa Fe office on April 2, 1956, from Aztec Oil & Gas Company requesting your Honorable Commission to deny this application.

The same quarter-section of land is involved in the subject application bearing your Docket No. NSP-251 as was involved in Case No. 992. Your Honorable Commission is, of course, aware of the fact that the hearing in Case 992 was had on January 19, 1956 and that an order has not yet been entered in said case.


Continental Oil Company will not be in position to prepare and present its case in support of the subject applica-

THE APPLICATION OF CONTINENTAL OIL COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS HAWK B-10 NO. 1 WELL, NW/4 NE/4 SECTION 10, TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM, LEA COUNTY, NEW MEXICO.

ORDER NO. DC-86

ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-316, Rule 112-A, Continental Oil Company made application to the New Mexico Oil Conservation Commission on March 8, 1954, for permission to dually complete its Hawk B-10 No. 1 Well, NW/4 NE/4 Section 10, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, and

The Secretary-Director Finds:

- (1) That application has been duly filed under the provisions of Sub-section 10 of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant herein, Continental Oil Company, be and it hereby is authorized to dually complete its Hawk B-10 No. 1 Well, NW/4 NE/4 Section 10, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, in such manner as to permit production of gas from the Tubb zone of the Tubb Gas Pool through the annular space between the casing and the tubing, and oil from the Drinkard zone of the Drinkard Oil Pool through the tubing, by proper perforations and the installation of a suitable packer;

PROVIDED HOWEVER, That subject well shall be completed and thereafter produced in such a manner that there will be no commingling within the well-bore, either within or outside the casing, of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED HOWEVER, That prior to the actual dual completion the operator shall make pressure tests of the casing to prove that no casing leaks have developed since the well was originally completed. In the event a casing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form C-103.

PROVIDED FURTHER, That upon the actual dual completion of such subject well applicant shall submit to the District Office of the Commission at Hobbs, New Mexico, copies of Oil Conservation Commission Form C-103, Form C-104, Form C-110 and Form C-122 outlining the information required on those forms by existing Rules and Regulations and two copies of the electric log of the well, if available.

PROVIDED FURTHER, That said subject well for dual completion and production shall be equipped in such a way that reservoir pressures may be determined separately for each of the two specified strata, and further, be equipped with all necessary connections required to permit recording meters to be installed and used, at any time, as may be required by the Commission or its representatives, in order that natural gas, oil, or oil and gas from each separate stratum may be accurately measured and the gas-oil ratio thereof determined, and

PROVIDED FURTHER, That the operator-applicant shall make any and all tests, including segregation tests, but not excluding other tests and/or determinations at any convenient time and in such manner as deemed necessary by the Commission; the original and all subsequent tests shall be witnessed by representatives of the Commission and by representatives of offset operators, if any there be, at their election, and the results of each test properly attested to by the applicant herein and all witnesses, and shall be filed with the Commission within ten days after completion of such test, and

PROVIDED FURTHER, That upon the actual dual completion of such subject well, applicant shall submit to the Commission a diagrammatic sketch of the mechanical installation which was actually used to complete and produce the seal between the strata, and a special report of production, gas-oil ratio and reservoir pressure determination of each producing zone or stratum immediately following completion.

IT IS FURTHER ORDERED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after proper notice and hearing the Commission may terminate the authority hereby granted and require applicant or its successors and assigns to limit its activities to regular single-zone production in the interests of conservation.



APPLICATION

Comes now CONTINENTAL OIL COMPANY, a Delaware Corporation, hereinafter called "Applicant" and respectfully requests the Oil Conservation Commission of the State of New Mexico to issue orders authorizing Applicant to dual complete its W. C. Hawk B-10 No. 1 well and allocate a non-standard production unit to the well, located 660 feet from the north line and 1980 feet from the east line of Section 10, T. 21S, R. 37E, N.M.P.M., Lea County, New Mexico, in the Drinkard Oil Pool and the Tubb Gas Pool, and in support thereof would show the followings:

A non-standard production unit of 120 acres consisting of contiguous quarter quarter sections, W/2 and the SE/4 of the NE/4, Section 10, T. 21S, R. 37E, is requested.

In support of this request we should like to point out that the proposed unit conforms with Commission requirements in all respects as follows:

1. Said unit consists of contiguous quarter quarter sections (and/or lots).
2. Said unit lies wholly within a single governmental section.
3. The entire proposed unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 2640 feet.
5. Copies of this application have been furnished by registered mail to all offset operators and all operators within 1500' of said well.

The dual completion of said well in the Drinkard for oil and the Tubb for gas is in the interest of conservation and the protection of correlative rights.

Segregation of the producing intervals will be made by appropriate packer installation and said well will be equipped so there can be no comingling of well fluids in producing the gas through the annulus between the tubing and casing, and the oil through the tubing. Said well will be equipped in such a manner that reservoir pressured may be determined separately for each of the two specified pools and the well head equipment to be equipped with all necessary connections to permit accurate measurement

of any natural gas, oil, or oil and gas produced from each separate pool as may be required by the Commission.


Attached to this application is a plat showing the location of said well and surrounding wells and leaseholds with the acreage to be assigned the proposed gas unit outlined in red, a plat showing the mechanical condition of said well at present and after the proposed dual completion.

All offset operators have been duly notified by copy of this application.

WHEREFORE, Applicant respectfully requests the Oil Conservation Commission of the State of New Mexico enter its order authorizing Applicant to dual complete said well and permit the assignment of a non-standard proration unit in accordance with the foregoing application and rules and regulations of the Commission.



Proposed Gas Unit


