Gentlemen:

Chevron U.S.A. Inc. respectfully seeks administrative approval to amend Order NSP-317 by deleting from the existing 320-acre Eumont Gas Proration Unit the SW/4 NW/4 of Section 24 (40-acres), T-21-S, R-36-E, making a 280-acre Eumont Gas Proration Unit dedicated to the Harry Leonard (NCT-J) Well No. 1.


This acreage reduction is due to a recent completion of Chevron's Harry Leonard (NCT-J) Well No. 2, located 1980 feet from the North line and 990 feet from the West line, Unit E, of said Section 24 as a Eumont Oil well. The deletion of the SW/4 NW/4 of said Section 24 from the 320-acre Eumont Gas Proration Unit will allow forming and dedicating a standard 40-acre oil spacing proration unit within said pool for Well No. 2.

The proposed Non-Standard 280-acre Eumont Gas Proration Unit will comprise the NW/4 NW/4, E/2 NW/4 and the NE/4 of Section 24, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico. It is requested that the 280-acre unit continue to be dedicated to the Harry Leonard (NCT-J) Well No. 1 located 1980 feet from the North and East lines, Unit G, of said Section 24.

Attached for your reference is an area map, Form C-102 plats, and a copy of Division Order NSP-317. A copy of this application is being furnished by Certified Mail to offset operators as their notice of this application.




Gentlemen:
