Arch Petroleum, Inc. respectfully request administrative approval for a non-standard Blinebry Gas Proration Unit for the Lee Stebbins B No. 3 well.

Arch Petroleum, Inc. is planning to add perfs to the Blinebry Gas zone in the existing inactive Blinebry Oil completion in the Lee Stebbins B No. 3 well. The location of the proposed recompletion is 660 feet FNL and 460 feet FEL of section 5, T22S, R37E, Lea County, New Mexico. This well is currently a dual completion well producing from the Tubb Gas with the Blinebry inactive and will become a non-standard Blinebry gas well location, as it is only 460 feet from the Section line.

The proposed non-standard gas proration unit would consist of the N 1/2 of the NE 1/4 of Section 5, T22S, R37E, Lea County, New Mexico.

Attached is a C102 identifying the proposed proration unit, a commercial map, a list of the offset operators, and a copy of the certified letter sent to the offset operators


