Your letter of April 5th, Administrative Order NSP-363, granted approval of a 160 acre non-standard gas proration unit in the Jalmat Gas Pool to be assigned to our Sholes B-19 No. 2 Well, located 990 feet from the North line and 2310 feet from the West line of Section 19, Township 25S, Range 37E, Lea County, New Mexico. Your letter lists the acreage to make up the 160 acre non-standard gas proration unit as follows:

Township 25 South, Range 37 East, NMPM  
E/2 NW/4 and W/2 NE/4 Section 9

Apparently, a typographical error may have been made in entering the section number as our records indicate the acreage is in Section 19 rather than Section 9 and the following would be the correct listing of this acreage:

Township 25 South, Range 35 East, NMPM  
E/2 NW/4 and W/2 NE/4 Section 19


Also, the last paragraph of the above mentioned letter

New Mexico Oil Conservation Commission  
Page 2

indicates that an allowable will be assigned after submission of proof of communitization to your Santa Fe and Hobbs Offices. This gas proration unit is comprised entirely of acreage under one basic lease which is owned by New Mexico Federal Unit Companies. Since communitization of New Mexico Federal Unit acreage with acreage owned by other interests is not involved in the formation of this proration unit, we do not believe the filing of proof of communitization to be applicable in this instance.

We call these matters to your attention in order to reconcile our records and for whatever action you deem necessary.
