

Our Sholes B-19 No. 2 was recently cleaned out and stimulated by sandfrac treatment. The test after completion of the work indicated the well to be an oil well under the definition given in order No. R-520. By letter dated August 27, 1958, your Hobbs office notified us that the well was being reclassified as an oil well. In accordance with that letter we hereby request that order No. NSP 363, which established a non-standard gas proration unit for this well, be cancelled.
