Administrative Order NSL-3340-A(SD)

Dear Mr. Howell:

Reference is made to your application dated April 17, 1996 for an unorthodox Eumont gas well location within an existing non-standard 320.07-acre gas spacing and proration unit ("GPU") for said Eumont Gas Pool comprising Lots 1 and 2, S/2 NE/4, and NW/4 of Section 1, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Administrative Order NSP-367, dated April 25, 1957 and had dedicated thereon the J. R. Phillips Gas Com Well No. 3 (**API No. 30-025-04132**), located at a standard gas well location 1980 feet from the North and East lines (Unit G) of said Section 1.

By Division Administrative Order NSL-3340(SD), dated January 11, 1994, a second well, the J. R. Phillips Gas Com Well No. 4 (**API No. 30-025-32358**), drilled at an unorthodox gas well location 1090 feet from the South line and 1330 feet from the East line (Unit O) of said Section 1, was approved for the subject GPU.

It is our understanding that the subject well in this application, the J. R. Phillips Well No. 1 (**API No. 30-025-04130**), is currently a temporarily abandoned oil well in the Eunice Monument-Grayburg San Andres Pool and upon issuance of this order will be recompleted as a gas well in the Eumont Gas Pool.

By authority granted me under the provisions of **Rule 2(d)** of the "*Special Rules and Regulations for the Eumont Gas Pool*", as promulgated by Division Order No. R-8170, as amended, the aforementioned J. R. Phillips Well No. 1, located at an unorthodox Eumont gas well location 330 feet from the North and East lines (Lot 1/Unit A) of said Section 1 is hereby approved.

Also, you are hereby authorized to simultaneously dedicate Eumont Gas production from the J. R. Phillips Gas Com Well Nos. 3 and 4 with the J. R. Phillips Well No. 1. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from all three wells in any proportion.



Reference is made to your application dated December 15, 1993, for an unorthodox Eumont gas well location in an existing non-standard 320.07-acre gas spacing and proration unit (GPU) for said Eumont Gas Pool comprising Lots 1 and 2, the S/2 NE/4 and NW/4 (E/2 equivalent) of Section 1, Township 20 South, Range 36 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Administrative Order NSP-367, dated April 25, 1957 and presently has dedicated thereon the J.R. Phillips Gas Com Well No. 3 located in Unit G of said Section 1.

By authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170 as amended, the following described well located at an unorthodox gas well location is hereby approved:

*J.R. Phillips Gas Com Well No. 4
1090' FSL - 1330' FEL (Unit O)*

Also, you are hereby authorized to simultaneously dedicate Eumont Gas production from the J.R. Phillips Gas Com Well No. 3 with the J.R. Phillips Gas Com Well No. 4. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from both said wells in any proportion.
