Gentlemen:

By this letter of application Amerada Petroleum Corporation wishes to state the following:

N/2 NW/4

(A) That Amerada Petroleum Corporation Caudle No. 7, located 660 feet from the North line and 1980 feet from the West line of Section 3, Township 12 South, Range 33 East, Lea County, New Mexico is a gas well completed in the Bagley-Lower Pennsylvanian Gas Pool.

(B) That the applicant proposes to assign this well a non-standard gas proration unit in the Bagley-Lower Pennsylvanian Gas Pool consisting of 80 acres which is the N/2 of the NW/4 of Section 3, Township 12 South, Range 33 East. (Attached Exhibit "A").

(C) That the proposed non-standard gas proration unit lies wholly within a single governmental section.

(D) That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

(E) That the proposed non-standard gas proration unit consists of contiguous quarter-quarter sections.

(F) That by copy of this letter of application all off-set operators are notified by registered mail of this proposed non-standard gas proration unit.


