Re: Application for a 160 acre non-standard gas proration Unit, Jalmat Gas Pool, comprising the NE $\frac{1}{4}$ of Sec. 17-22S-36E, Lea County, New Mexico.

Gentlemen:

Cities Service Oil Company hereby makes application for approval of a non-standard gas proration unit comprising the NE $\frac{1}{4}$ of Sec. 17-22S-36E, Lea County, New Mexico, and in support thereof states the following facts.

1. State "H" #2 is located 1980' from the North line and 660' from the East line of Sec. 17-22S-36E, Lea County, New Mexico and was completed August 12, 1957 as a Jalmat Gas Pool Well.
2. An exception to Rule 5 (a) Order 520 is requested in order to assign the State "H" #2 a 160 acre non-standard gas proration unit. This non-standard gas proration unit consists of contiguous quarter/quarter sections within a single governmental section and the entire area may reasonably be presumed to be productive of gas.
3. The attached plat indicates the acreage to be assigned to this well and the offset ownership.
4. All operators owning interests in Section 17 and within 1980' of the State "H" #2 have been furnished copies of this request by registered mail.

In view of the existence of the above facts herein stated and compliance with the provisions of Rule 5 (a) of the Oil Conservation Commission's Order No. R-520, Cities Service requests the Commission approve the above described non-standard gas proration unit.

SECTION _____ TOWNSHIP 22 S RANGE 36 E COUNTY LEA STATE NEW MEXICO


