Gentlemen:

Reference is made to your application for approval of a 320-acre non-standard gas proration unit in the Jalmat Gas Pool consisting of the following acreage:

Township 22 South, Range 36 East

See con 17: W/P

It is understood that this unit is to be ascribed to your State E-17 Well No. 5 located 1980 feet from the South line and 330 feet from the West line of said Section 17.

By authority granted me under provisions of Rule 5, Section (b) of the Special Rules and Regulations for the Jalmat Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with Rule 8 of the pool rules, based upon the unit size of 320 acres. The non-standard 160-acre proration unit heretofore ascribed to your State E-17 Well No. 5, comprising the SW/4 of Section 17, and the non-standard 160 acre proration unit heretofore ascribed to your State E-17 Well No. 4, comprising the NW/4 of Section 17, are hereby cancelled.
