Dear Sir:

Under the provisions of Order R-316, Rule 112A of the Commission's Rules and Regulations, R. Olsen Oil Company makes application for administrative approval to dually complete and produce its State B No. 1 in the Eumont Field. This dual completion will be effected to produce Queen gas from formations through tubing-casing annulus and oil from the Grayburg zone through the tubing by installation of suitable packer equipment.

Also, under the provision of Commission Order No. R-520, Rule 5 (b) Special Rules and Regulations for the Eumont Gas Pool, delegating the Secretary of the Commission authority to grant exceptions to the requirement of Rule No. 5 (a) without notice and hearing for a non-standard gas proration unit, R. Olsen Oil Company hereby applies for an exception to subject rule for State B No. 1, Eumont Field, to be dually completed as a gas-oil well.

In support of the above application, the following data are furnished:

1. The application is submitted in triplicate.
2. Complete legal description of acreage involved:  
S/2 of the SW/4 of Section 18, T-21-S, R-37-E, NMPM,  
Lea County, New Mexico.
3. Exact location and name of well involved:  
State B No. 1, located 990' from the South line  
and 2310' from the East line of Section 18, T-21-S,  
R-37-E, NMPM, Lea County, New Mexico.
4. Attached plat showing:
  - (a) Acreage to be dedicated.
  - (b) Well location.
  - (c) Offset ownership.

5. Attached diagrammatic sketch of proposed dual completion equipment showing:
  - (a) Formation involved.
  - (b) Perforations.
  - (c) Approximate location of packer.
  - (d) Other information pertinent to dual completion.
6. Details of Recompletion:

The subject well is currently completed as an oil well in the Grayburg formation. It is planned to perforate and stimulate the Queen formation and complete the well as a gas-oil dual.
7. The proposed non-standard gas proration unit of 80 contiguous acres consists of the S/2 of the SW/4 of Section 18, T-21-S, R-37-E.
8. The proposed non-standard gas proration unit lies wholly within a single governmental section.
9. The entire proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
10. The length or width of the proposed non-standard gas proration unit does not exceed 5280'.
11. All operators who offset the lease containing location of the subject well have been furnished a copy of this application by registered mail. Attached is mailing list of all operators notified.


