Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

TOWNSHIP 22 SOUTH, RANGE 36 EAST, NMPM  
Section 13: NE/4

It is understood that this unit is to be dedicated to your State McDonald A/C 2 Well No. 11, located 330 feet from the North line and 330 feet from the East line of said Section 13.

By authority granted me under provisions of Rule 5 (b), of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with the pool rules, based upon the unit size of 160 acres.

Dear Mr. Kacir:

Reference is hereby made to your application dated June 25, 1999. Marathon Oil Company ("Marathon") is hereby authorized to simultaneously dedicate Eumont Gas Pool production to the previously approved non-standard 160-acre gas spacing and proration unit ("GPU") comprising the NE/4 of Section 13, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico (see Division Administrative Order NSP-439, dated August 19, 1958), from the two following described wells:

- the original McDonald State "A/C-2" Well No. 11 (API No. 30-025-08897) located at an unorthodox gas well location 330 feet from the North and East lines (Unit A) of Section 13 (approved by Division Administrative Order NSL-160, dated August 28, 1958); and
- the existing McDonald State "A/C-2" Well No. 31 (API No. 30-025-25932), recently recompleted up-hole from the Drinkard Pool and located at a standard gas well location 1800 feet from the North line and 1650 feet from the East line (Unit G) of Section 13.

Marathon is permitted to produce the allowable assigned this non-standard 160-acre unit from both wells in any proportion.
