Reference is made to your application for approval of a 480-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

TOWNSHIP 22 SOUTH, RANGE 36 EAST, NMPM
Section 13: S/2 and NW/4

It is understood that this unit is to be dedicated to your State McDonald A/C 2 Well No. 26, located 1980 feet from the North and East lines of said Section 13.

By authority granted me under provisions of Rule 5 (b), of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with the pool rules, based upon the unit size of 480 acres.

Administrative Order NSP-440-B

Dear Mr. Gaddis:

Reference is made to your applications dated May 8 and 13, 1996 to abolish the existing 440-acre non-standard gas spacing and proration unit ("GPU") in the Eumont Gas Pool comprising the NW/4 and S/2 of Section 13, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, which was approved by Division Administrative Order NSP-440, dated August 19, 1958, as amended by Division Administrative Order NSP-440-A, dated September 10, 1958, and currently dedicated to the McDonald State A/C-2 Well No. 26 (API No. 30-025-08909), located at a standard gas well location 1980 feet from the South and East lines (Unit J) of said Section 13, and form the two following described non-standard GPU's for Eumont gas production:

- (a) 160 acres comprising the NW/4 of said Section 13 is to be dedicated to the McDonald State A/C-2 Well No. 35 (API No. 30-025-33397), located at a standard gas well location 1980 feet from the North line and 660 feet from the West line (Unit E); and,
- (b) 120 acres comprising the NW/4 SE/4 and S/2 SE/4 of said Section 13 is to be dedicated to said McDonald State A/C-2 Well No. 26 in Unit "J".

By authority granted me under the provisions of Rule 2(d) of the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Eumont Gas Pool", as promulgated by Division Order No. R-8170, as amended, the two above-described non-standard gas spacing and proration units are hereby approved.

Both Division Administrative Orders NSP-440 and NSP-440-A shall be placed in abeyance until further notice.
