Gentlemen:

Reference is made to your letter of June 11, 1962, wherein you have requested re-allocation of the acreage assigned to your New Mexico State V-11 Blinebry gas well, located in Unit K, Section 10, Township 21 South, Range 37 East, to include only the E/2 of the SW/4 of Section 10 rather than the E/2 of the SW/4 and the NW/4 SW/4 as presently allocated under authority of Administrative Order NSP-469. The reduction in dedicated acreage from 120 acres to 80 acres is the result of the completion of your New Mexico State Well No. V-12 in Unit L of Section 10 as a Blinebry oil well.

Administrative Order NSP-469 is hereby amended to include only the E/2 of the SW/4 of the above-described Section 10.

Gentlemen:

Reference is made to your application for approval of a 120-acre non-standard gas proration unit in the Blinebry and Tubb Gas Pools consisting of the following acreage:

TOWNSHIP 21 SOUTH, RANGE 37 EAST, NMPM  
Section 10: N/2 SW/4 and SW/4 SW/4 (Tubb Unit)  
N/2 SW/4 and SE/4 SW/4 (Blinebry Unit)

It is understood that this unit is to be dedicated to your State "V" Well No. 11, located 2080 feet from the South line and 2080 feet from the West line of said Section 10.

By authority granted me under provisions of Rule 5 (d), of the Special Rules and Regulations for the Tubb Gas Pool and Rule 5 (B) of the Special Rules and Regulations for the Blinebry Gas Pool, as set forth in Orders R-586 and R-610 respectively, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with the pool rules, based upon the unit size of 120 acres.
