
Dear Mr. Westbrook:

Reference is made to your application of December 4, 1989 for a non-standard gas well location for your Wood "A" State Well No. 3 located 2310 feet from the North line and 1650 feet from the West line (Unit F) of Section 16, Township 20 South, Range 37 East, NMPM, Eumont Gas Pool, Lea County, New Mexico, which is presently shut-in in the Monument-Tubb zone.

Said well to be dedicated to the previously approved non-standard 80-acre gas spacing and proration unit comprising the E/2 NW/4 of said Section 16 (Division Administrative Order NSP-476, dated March 18, 1959). Said unit is presently dedicated to the applicant's Wood "A" State Well No. 2 located 1980 feet from the North line and 1650 feet from the West line (Unit F) of said Section 16; however, it is our understanding that the No. 2 well has been sold to Amerada Hess Corporation and the Eumont zone will subsequently be abandoned.

By the authority granted me under the provisions of Rule 2(c) of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, the above-described unorthodox gas well location is hereby approved.

Gentlemen:

On February 12, 1959, Oil Well Drilling Company requested administrative approval of a proposed non-standard proration unit for its Wood State A Well No. 2 located 1980 feet south of the north line and 1650 feet east of the west line of Section 16, T20S, R37 E, Lea County, New Mexico in the Eumont gas pool.

80 acres

Through error we applied for a proposed unit consisting of 40 acres, however the proposed unit consists of 80 acres comprised of the East 1/2 of the NW/4 of Section 16, T20S, R37E.

We have just recompleted the above captioned well as a Eumont gas well. Completion data will be furnished the Commission when we have all the necessary information.

In view of the facts set out herein and in our letter of February 12, 1959, we respectfully request that the Commission issue an order approving the 80 acre non-standard unit for Oil Well Drilling Company's Wood State A Well No. 2.
