Re: Application of Gulf Oil Corporation for the Cancellation of a Standard 160 Acre Gas Proration Unit and Approval of a Non-Standard 120 Acre Gas Proration Unit, Blinebry Gas Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670 which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval for the cancellation of a Standard 160 Acre Blinebry Gas Proration Unit covering the NE $\frac{1}{4}$  Section 32, Township 22 South, Range 38 East, Lea County, New Mexico and exception to Rule 5(A) of Order No. R-1670 for the approval of a Non-Standard 120 Acre Blinebry Gas Proration Unit covering the E/2 NE $\frac{1}{4}$  and the SW $\frac{1}{4}$  NE $\frac{1}{4}$  of this Section 32 in the Blinebry Gas Pool of Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's T. R. Andrews Well No. 2 located 1980 feet from the east and north lines of Section 32, Township 22 South, Range 38 East, is completed in the Blinebry Gas Pool and has been assigned a standard 160 acre gas proration unit covering the NE $\frac{1}{4}$  of this Section 32.
- (2) Gulf's T. R. Andrews Well No. 1 located 660 feet from the north line and 1980 feet from the east line of Section 32 has been dually completed as an oil well in the Blinebry Pool.
- (3) The proposed Non-Standard Gas Proration Unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- (4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2640 feet.
