Gentlemen:

In compliance with Rule 30, Order No. R-1670 which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval for the cancellation of a standard 160 acre Blinebry Gas Proration Unit covering the NE/4 Section 22, Township 21 South, Range 37 East, Lea County, New Mexico, and exception to Rule 5(a) of Order No. R-1670 for the approval of a non-standard 120 acre Blinebry Gas Proration Unit covering the E/2 NE/4 and the SW/4 NE/4 of this Section 22 in the Blinebry Gas Pool of Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's Eubanks Well No. 4 located 660' FEL and 1980' FNL of Section 22, Township 21 South, Range 37 East, is completed in the Blinebry Gas Pool and has been assigned a standard 160 acre gas proration unit covering the NE/4 of this Section 22.
- (2) Gulf's Eubanks Well No. 5 located 330' FNL and 2310' FEL of Section 22 has been completed as an oil well in the Blinebry Pool.
- (3) The proposed Non-Standard Gas Proration Unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- (4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2,640 feet.

- (6) All operators in this quarter section and within 1,500 feet of the unit well have been furnished a copy of this application.

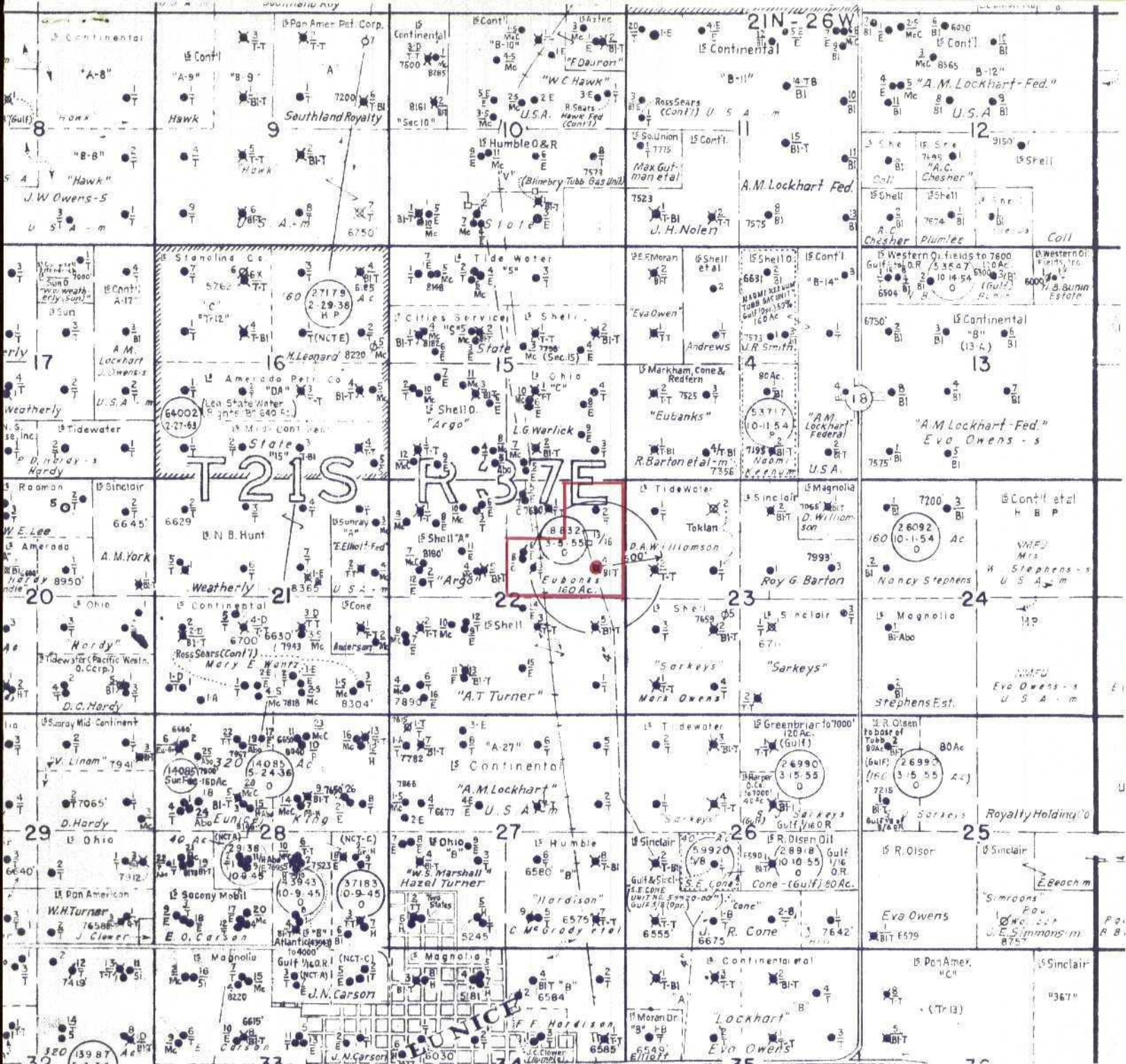

Gentlemen:

In compliance with Rule 30, Order No. R-1670 which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a non-standard 40-acre Blinebry gas proration unit covering the SE/4 NE/4 of Section 22, Township 21 South, Range 37 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's Eubanks Well No. 4, located 660 feet from the east line and 1980 feet from the north line of Section 22, Township 21 South, Range 37 East, is completed in the Blinebry Gas Pool and has been assigned a standard 160-acre gas proration unit covering the NE/4 of this Section 22. Gulf's application dated May 2, 1961, requested that this unit be reduced to 120 acres due to the completion of Well No. 5, located in the NW/4 NE/4 as a Blinebry oil well.
- (2) Gulf's Eubanks Well No. 3, located 2080 feet from the east line and 1980 feet from the north line of this Section 22 has now been completed as a Blinebry oil well.
- (3) It is proposed to also recomplete the Eubanks Well No. 2, NE/4 NE/4 of Section 22 as a Blinebry oil well.
- (4) The proposed non-standard gas proration unit consists of a quarter-quarter section and lies wholly within a single governmental quarter section.
- (5) The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (6) The length or width does not exceed 2640 feet.

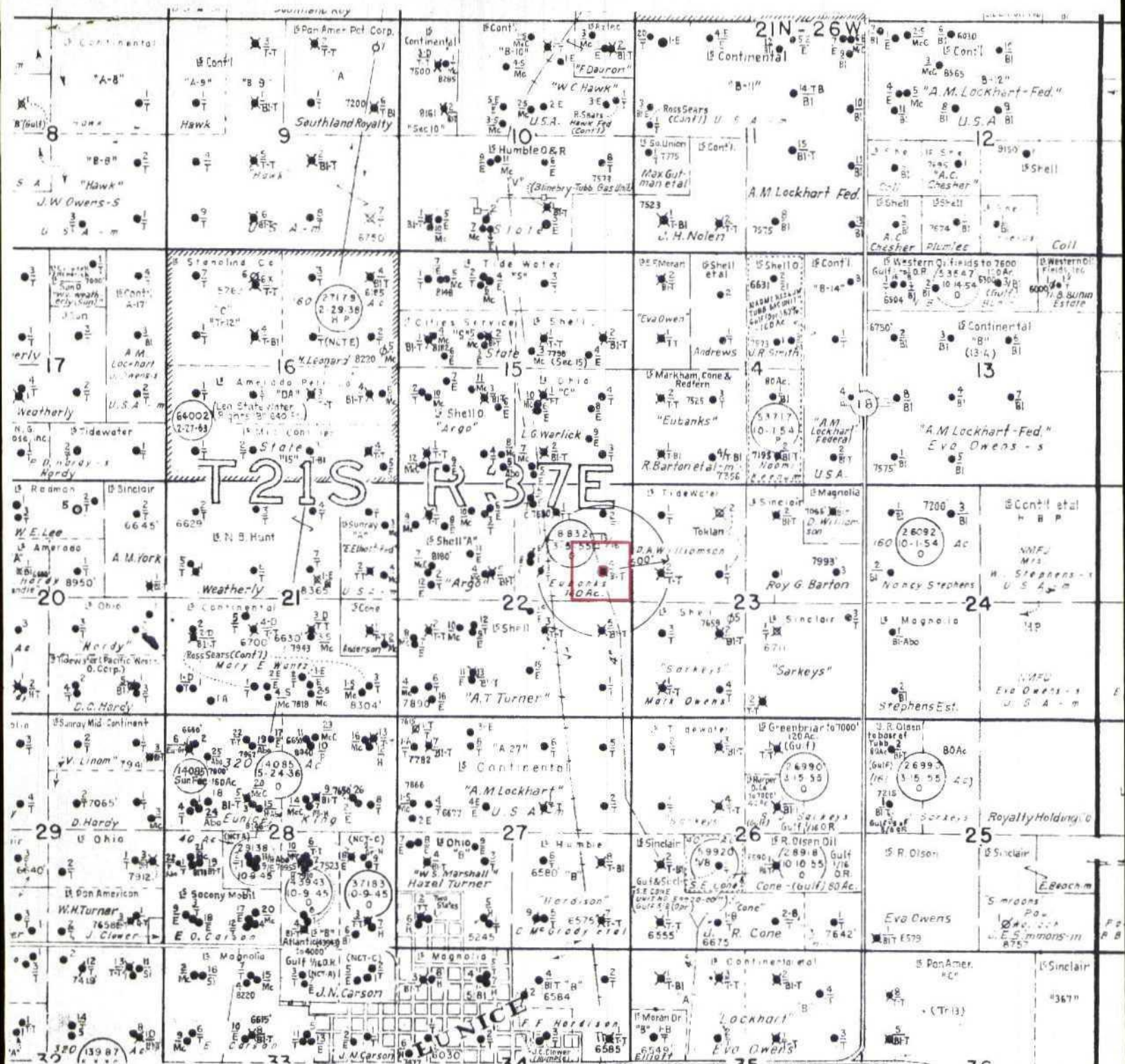
