Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a Non-Standard 120-acre Blinebry Gas Proration Unit covering the E/2 NE/4 and NW/4 NE/4 of Section 10, Township 22 South, Range 37 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's Eaves Well No. 6, located 554 feet from the north line and 766 feet from the east line of Section 10-22S-37E is completed in the Blinebry Gas Pool and has been assigned a Standard 160-acre Gas Proration Unit covering the NE/4 of this Section 10.
- (2) Gulf's Rollon Brunson Well No. 4, located 1874 feet from the east line and 2086 feet from the north line of this Section 10 has now been completed as a Blinebry oil well.
- (3) The proposed Non-Standard Gas Proration Unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- (4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) All Operators in this quarter section and within 1500 feet of the Unit well have been furnished a copy of this application.

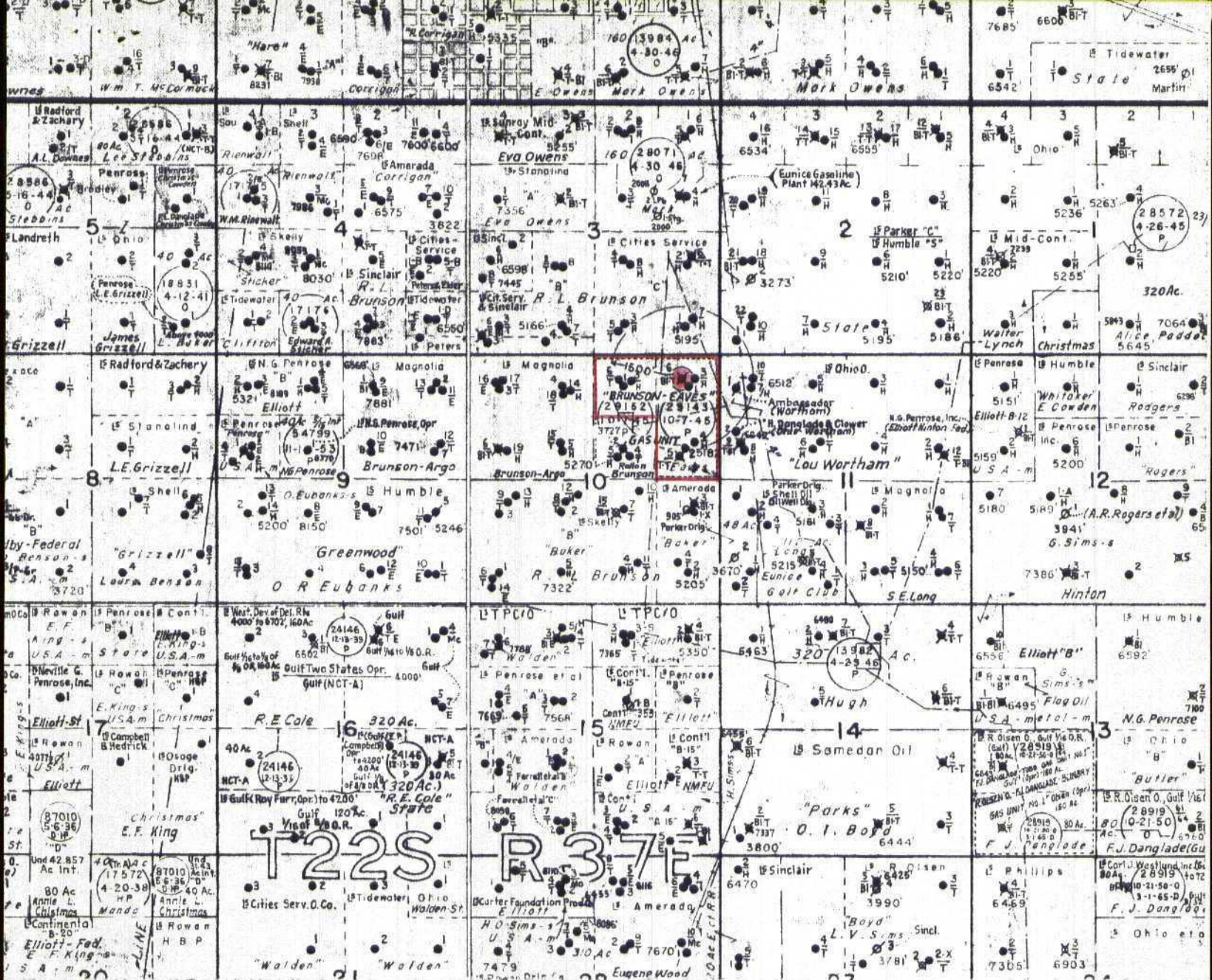
