for the Approval of a Non-Standard  
80-Acre Gas Proration Unit, Blinebry  
Gas Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests exception to Rule 5A of Order No. R-1670 for the approval of a non-standard 80-acre Blinebry gas proration unit covering the S/2 NW/4 Section 28, Township 21 South, Range 37 East, Lea County, New Mexico.

In support of this application the following facts are submitted:

1. Gulf's Eunice King Well No. 5, located 1874 feet from the north and west lines of Section 28, Township 21 South, Range 37 East, is completed in the Blinebry Gas Pool and has been assigned a standard 160-acre gas proration unit covering the NW/4 of this Section 28. Gulf's application dated July 19, 1961, requested the approval of a non-standard 120-acre gas proration unit for this well, covering the E/2 NW/4 and SW/4 NW/4.
2. Gulf's Eunice King Well No. 19, located 660 feet from the north line and 1980 feet from the west line of this Section 28, has been completed as a Blinebry oil well.
3. The proposed non-standard gas proration unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
4. The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.

5. The length or width does not exceed 2640 feet.
6. All operators in this quarter section and within 1500 feet of the unit well have been furnished a copy of this application.


