Gentlemen:

Receipt by the Commission of your application for approval of a non-standard 120-acre gas proration unit, Blinebry Gas Pool, Lea County, New Mexico, dated September 12, 1961, is acknowledged.

Your attention is directed to the Commission's Order No. R-1670, Rule 5(C), 6 (b), which requires the presentation by the applicant of written consent in the form of waivers from all operators owning interests within 1500 feet of the well to which such non-standard gas proration unit is proposed to be dedicated. In lieu of such written consent, the applicant may furnish proof of the fact that the offset operators were notified by registered mail of his intent to form such non-standard gas proration unit. If the latter course should be chosen, the Commission will wait 30 days from the date such proof is furnished and if no objection is received, will approve the application.

Your application is being held in abeyance until you have furnished either written consent from the offset operators, or proof of the fact that they have been notified.

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests exception to Rule 5 (a) of Order No. R-1670 for the approval of a non-standard 120-acre Blinebry gas proration unit covering the W/2 NE/4 and NE/4 NE/4 of Section 28, Township 21 South, Range 37 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's Eunice King Well No. 9, located 1874 feet from the north and east lines of Section 28 is completed in the Blinebry Gas Pool and has been assigned a standard 160-acre gas proration unit covering the NE/4.
- (2) Gulf's Eunice King Well No. 8, located 1980 feet from the north line and 660 feet from the east line of this Section 28 has been recompleted as a Blinebry oil well.
- (3) The proposed non-standard gas proration unit consists of contiguous quarter-quarter sections and lies wholly within a single Governmental quarter section.
- (4) The entire non-standard proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2640 feet.


