Gentlemen:

In compliance with Rule 30, Order No. R-1670 which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a Non-Standard 80-Acre Blinebry Gas Proration Unit covering the E/2 NE/4 of Section 16, Township 21 South, Range 37 East, Lea County, New Mexico.

In support of this application, the following facts are submitted:

- (1) Gulf's Harry Leonard (NCT-E) Well No. 4, located 660 feet from the north and east lines of Section 16, Township 21 South, Range 37 East, is completed in the Blinebry Gas Pool and is assigned a non-standard 120-acre gas proration unit by Order NSP-562 covering the E/2 NE/4 and SW/4 NE/4 of this Section 16.
- ✓(2) Gulf's Harry Leonard (NCT-E) Well No. 1, located 1980 feet from the north and east lines of this Section 16, has been recompleted as a Blinebry oil well.
- ✓(3) The proposed Non-Standard Gas Proration Unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- ✓(4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- ✓(5) The length or width does not exceed 2640 feet.

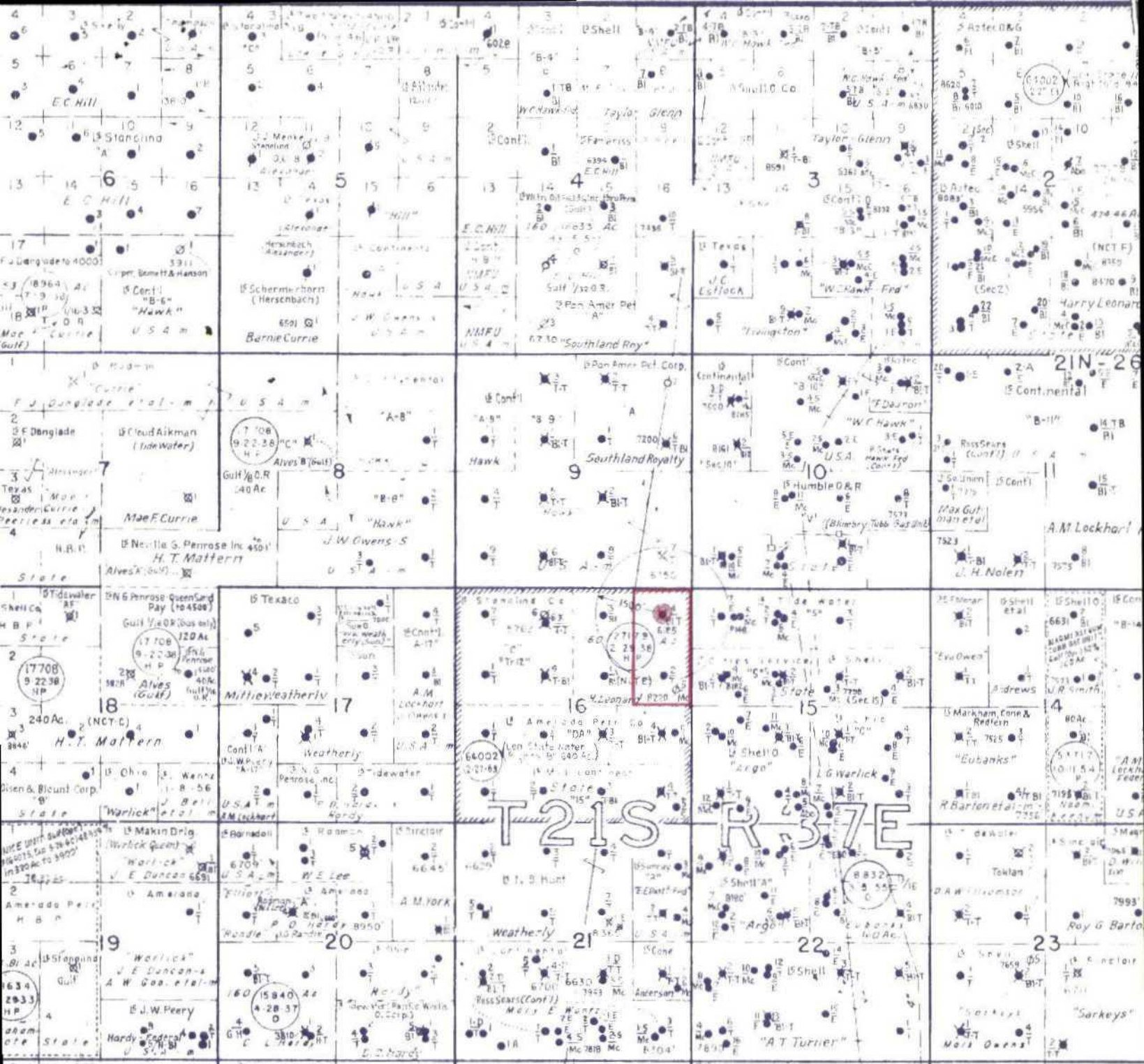
