Gentlemen:

In accordance with Order R-1670 applicable to prorated gas pools in Southeastern New Mexico, and applicable provisions of such order to the Eumont Gas Pool, we respectfully request an administrative exception to Rule 5-a for the assignment of 40 acres to our gas well located in the NE of the NW of Section 29, Township 21 South, Range 36 East. Such proposed non-standard proration unit consists of acreage less than the standard 640 acre proration unit in the Eumont Gas Pool. Such non-standard gas proration unit consists of a quarter quarter section lying wholly within a single governmental section and can reasonably be presumed to be productive of gas from the Eumont Pool, since it is completed within the vertical limits of such Eumont Gas Pool and defined by the Commission.

This well was formerly an oil well, and the gas production from such well has been increasing and the oil production decreasing since the work-over of this well was completed in September 1959. In accordance with the Commission's ruling, a gas-oil ratio test was recently taken on this well and reported to the Commission, showing the well producing 15,305 MCFGPD and no oil, therefore, we are requesting that this well be reclassified as a gas well to comply with the existing rules for the Eumont Pool.

At the present time we are seeking a market for the high pressure gas, and until such time as a connection is found for the well, we are attaching plat and Commission Form C-128, and as soon as a gas connection is secured we will file the appropriate notice of gas connection and the date that such connection has been made.




