Non-Standard 40-Acre Gas Proration Unit, Blinebry Gas
Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a non-standard 40-acre Blinebry Gas Proration Unit covering the NE/4 SE/4 of Section 31-22S-38E, Lea County, New Mexico. This non-standard unit is to be attributed to the Scarborough Estate Well No. 3. In support of this application the following facts are submitted:

- (1) Applicant's Scarborough Estate Well No. 3, located 660 feet from the east line and 1,980 feet from the south line of Section 31 is completed in the Blinebry Gas Pool and is assigned a 120-Acre Non-Standard Gas Proration Unit covering S/2 NE/4 and the NE/4 SE/4 by Administrative Order NSP-563 dated August 31, 1961.
- (2) Applicant's Scarborough Estate Well No. 2, located 1,880 feet from the north line and 660 feet from the east line of this Section 31, is being dually completed in the Blinebry Oil and Tubb Gas Pools.
- (3) The proposed Non-Standard Gas Proration Unit consists of a quarter-quarter section within a single governmental quarter section.
- (4) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2,640 feet.
- (6) All operators in the quarter section in which the proposed Non-Standard Unit is located and within 1,500 feet of the Unit Well have been furnished a copy of this application.


